2. Hon'ble Vice-Chancellor's Approval dated 7th March, 2020

With reference to the above and by the directions of the Hon'ble Vice-Chancellor, this is to inform you that, the University shall Provide Financial Assistance to the deserving Projects of Undergraduate final year students.

The following are the salient features of the proposed assistance:

- 1. The Financial Assistance shall be for the projects of Under Graduate final years student only. A sum of Rs. 5,000 (Rupees Five thousand only) per project with a maximum of two projects per branch/ programme shall be given by the University.
- 2. The Financial Assistance shall be available for all branches at Under Graduate level offered by the College.
- 3. The top two deserving projects (in each branch) shall be chosen by the Committee in respective College.
- 4. Each College shall constitute the Committees (branch-wise) and the composition shall be as follows.

i) Principal

-Chairman

ii) HoD of the respective Branch

- Member

iii) Three subject experts / Senior Professors/ Industries as deemed for by the Institution in each branch.
